- Program Name: Anti-Corruption Initiative of the Stability Pact for South Eastern Europe.
- Description: The members of the Stability Pact for Southeastern Europe have adopted an Initiative designed to combat corruption in the region. The Initiative is intended to fight corruption on all levels, including international commercial transactions, money laundering and other fraudulent and criminal activities. The Initiative covers the following five sectors; ratification and implementation of relevant international instruments, promotion of good governance and reliable public administrations (including procurement legislation), reinforcement of legislation (including on money laundering) and promotion of the rule of law, promotion of transparency and integrity in business operations, and promotion of an active civil society. The Initiative is based upon a three-stage process of diagnosis of the current conditions in the countries, country-specific recommendations and monitoring of progress. The first two phases will be completed for all countries before the end of the year and will result in a clear work plan for each country. Monitoring is a permanent process.
