First, the Communication on Fighting Corruption in the EU served to set up an EU anti-corruption reporting mechanism for periodic assessment of the Member States. Secondly, the Communication on an
	Anti-Fraud Strategy provides a framework for fighting fraud affecting the EU











financial interests. In 2011 the Commission also adopted its proposals on public procurement as part of an overall programme aimed at an in-depth modernization of public procurement in the European Union. Purpose of this session is to present successful initiatives aimed at identifying and reducing corruption in public procurement in their respective countries/institutions and the level of transposition of international / EU acquis in the local level.

Open Contracting


Public contracting refers to norms and practices for increased disclosure and participation in public contracting including tendering, performance and completion. It includes the variety of contract types, from more basic contracts for the procurement of goods, to complex contracts, joint venture agreements, licenses and production sharing agreements. Open contracting encompasses all public contracting, including contracts funded by combinations of public, private and donor sources. Aim of this session is to present experiences from international organizations, institutions and non-governmental organizations on innovative initiatives on open contracting.





	The discussion on corruption / integrity risk assessment in South Eastern Europe (SEE) is timely. However, the incontestable fact is that there is no and can be no "one size fits all" approach neither in fight against corruption nor in corruption prevention. Therefore, Regional Cooperation Council and Regional Anti-Corruption Initiative have developed Corruption Risk Assessment Methodology to provide SEE countries with different options, integrated framework and practical advices to conduct tailored corruption risk assessment efficiently and comprehensively, and consequently improve or upgrade governance and management of public sector institutions on integrity grounds.
	In addition, this conference will be utilised to seek endorsement of national counterparts of 10 Principles on Effective Corruption Risk Assessment in Public Administration: Corruption Risk Assessment, Public Procurement, Public Contract.
